***These Conditions of Use must be read and signed as understood and accepted before entering the Davos Adventure Park. Supervising adults of children under the age of 14 years must first explain the Conditions of Use to the user and confirm agreement with a signature.***

1. Minimum age for the **children's trail** are 4 years. **Children must be accompanied and supervised by a parent or a legal guardian. Each parent or guardian can supervise maximum two children on the children's trail.**
2. Minimum age for the **other trails** are 7 years, minimum height 130 cm. **Children from age 7 to 10 must be accompanied by an adult (maximum two children per adult) and children from age 11 to 13 must have adult supervision (maximum 4 children per adult).** Maximum permitted weight per user is **120 kg**.
3. **The park is not monitored;** the park staffs provide instruction, monitoring and assistance. **Visitors enter the Davos Adventure Park course independently and at their own risk.**
4. Insurance is a matter of the user
5. The Davos Adventure Park is open to users who do not suffer from any illness or other physical or mental condition, which could be of danger to their own, or another person's health whilst using the park. Persons under the influence of alcohol, drugs or strong medication are not permitted to use the park.
6. Items that may pose a danger to the users themselves or to other persons (jewellery, mobile phones, cameras etc.) may not be taken into the Davos Adventure Park. Long hair and loose clothing must be secured. Sporty clothing and good (closed) footwear are recommended.
7. **Users must participate in the entire theoretical and practical safety instruction before using the park.** The user has to ask and clarify any points that are unclear during instruction.
8. Equipment on loan (helmet, climbing harness, etc.) must be strictly used in accordance with instructions and have to be returned after the visit. Any damage to the equipment must immediately be reported to the staff.
9. It is forbidden to throw or leave objects or any waste on the ground. Please use the provided garbage cans in the park. Smoking, eating or drinking on the trails is not permitted.
10. The stay in the Davos Adventure Park is limited to three hours (liability to subsequent payment). **There is no entitlement to any refund of the admission fee should staff be forced to close the Davos Adventure Park due to force majeure.** This rule also applies when the user finishes its visit earlier or is excluded from continuing.

- 11. **All instructions and decisions made by the staff are strictly to be followed.** Non-observance or violation of rules and violation of these Conditions of Use can result in the immediate exclusion from the park.
- 12. **The sports facility Adventure Park of the municipality of Davos accept no liability whatsoever for any damage which may relate (directly or indirectly) to the use of the Davos Adventure Park.** The sports facility Adventure Park specifically refuses liability for non-observance, evasion or violation of these Conditions of Use.
- 13. The employees of the Adventure Park always have the right to check the identity of the user and their accompanying persons. If there is no prove of identity the user and their accompanying persons can be excluded from the entrance.
- 14. The place of jurisdiction is Davos. Swiss law is exclusively applicable.
- 15. **Your signature confirms to have completed this form correctly and truthfully and to have accepted these Conditions of Use.**
